

Special Meeting 6:00 P.M. May 3, 2021

Council met in special session at 6:00 p.m. on Monday, May 3, 2021 with Mayor Burk presiding. Meeting was called to order and roll call was taken. The following councilmembers were present: Rogers, Wood, Patterson, Johnston, Ranes and Davis. Councilmember Butts was not present. Administrator Gress and City Clerk were present.

Invocation was given by Mayor Burk.

- 1. Closure of Streets for Mayfest: Council reviewed the proposed street closures for the upcoming events for Mayfest. Motion was made by Johnston; seconded by Wood authorizing the City Administrator to work with the Mayfest Committee and the Car Show Committee to block off street. 6-0 Motion Carried
- 2. First Place Prize for Turtle Races: Request was made to allow the city to give out swim passes to all first place winners in each age group for Turtle Races. Motion was made by Johnston; seconded by Wood to have the City Clerk look at what was done in the past and prepare the passes. 6-0 Motion Carried
- 3. Beer Garden During Concert: Jared Daniels ask for council to allow him to do a beer garden during the concert. Would like to set it up and block off from State St. to Spring St. on 4th Ave. Motion was made by Johnston; seconded by Patterson to approve request. 6-0 Motion Carried
- 4. Review of the Agenda for Caney 150th Celebration: Council discussed purposed agenda. No Action Taken
- 5. Discussion of Four Friday Events During the Summer: Jarred Daniels would like to continue with doing concerts during the summer and to do them on the fourth Friday of each month. Before each event he will bring to council a request to have a beer garden and block off streets. Motion was made by Johnston; seconded by Wood to move forward with this. 6-0 Motion Carried
- 6. Purchase of Safe Work Signage: City Administrator let council know that the city does not have any type of safe work zone signs when the city crew is working on leaks or making road repairs. Would like to purchase signs from Rice Signs and he presented a quote in the amount of \$3,106.88. The cost of the signs would be paid out of Fund 19. Motion was made by Johnston; seconded by Patterson to purchase the signs. 6-0 Motion Carried
- 7. Replace Stolen Trailer: City Administrator would like to go ahead and replace the stolen city trailer now. The office is working with the insurance company on insurance claim and with the information we have received from them so far it appears with the purposed replacement trailer the city will be out of pocket approximately \$3,299.00. Motion was made by Johnston; seconded by Wood to purchase the new trailer. 6-0 Motion Carried

DISCUSSION ITEMS:

- May 20th will be the Highway Ribbon Cutting recognizing the completion of Highway 75 with Kansas Officials Present
- Up graded the meat grinder and bone saw at the grocery store
- Phase II Sewer Project is looking at a possible increase of \$1.8 million to complete the project. Sewer infrastructure is in worse shape than expected along with the South End Interceptor needing replaced.

Motion was made by Rogers; seconded by Johnston to adjourn meeting. 6-0 Motion Carried. Meeting adjourned at 7:45.
